**IMPORTANT: There is no full time cut-off for tuition in the summer.**  
 For each credit above 10, add \$315 per resident undergraduate credit and \$347 per resident graduate credit. For non-residents, add \$325 per undergraduate credit and \$357 per graduate credit.

- Fees are based on student status (undergraduate vs. graduate); **not** on the level of the course(s) taken.
- Students who audit summer courses pay full tuition for those classes.

**PAYMENT DEADLINES--No billing statements are mailed to students.** *It is your responsibility to be aware of tuition and fee amounts and payment deadlines!*

- 1) Payment deadlines for summer are—
  - **May 23** for courses beginning between May 5 and June 1 and all **“Arranged”** courses.
  - **June 20** for courses beginning between June 2 and July 25.
- 2) **Tuition is due on the published deadlines.** You can check your balance online. Go to [myWSU](http://myWSU) and click on “Finances”.
- 3) A \$50 late payment fee will be added to your account if tuition is not paid in full by **Friday, July 11**. *Courses taken through other WSU campuses, including DDP, are subject to the specific campus late payment deadlines and charges.*

**If you are registering or adding classes late, you are still subject to the late payment fee on July 11.** You can print a copy of your student account by accessing the information in [myWSU](http://myWSU) under “Finances.”

**REFUNDS**

Summer session fees are refunded in full when you officially drop courses or cancel your enrollment prior to the refund deadline dates (see [“Enrollment Change Deadlines”](#) chart). After the refund deadline for each course, no refund or credit for tuition is given for course withdrawals. **Fees are adjusted for drops and adds during the refund period only.** After the refund deadline, tuition cannot be transferred from a dropped course to an added course. Any course added after the refund deadline will result in additional tuition being charged at the time the course is added. Summer Session audit fees are refundable according to the published refund deadline dates. Faculty/Staff registration fees are non-refundable.
