

# State Legal Status and Perceptions of Consequences of Cannabis Among Users and Nonusers

# INTRODUCTION

- As more states legalize cannabis for medical and recreational use, it is important to understand changing attitudes about the benefits and risks of use.
- Perception of cannabis use as risky has decreased, the percentage of U.S. adults favoring legalization of recreational use has increased (Carliner et al., 2017).
- Research Question: Do perceptions of risks and benefits of cannabis use vary by U.S. state legal status?
- We hypothesized that current users and those whose reside in legal recreational states would perceive more benefits and fewer risks of use.

# METHODS

# Participants & Method

- Adult cannabis users (N=254) and nonusers (n=235) from a U.S. national online research panel. Data were collected in April 2020.
- 60.9% female, 82% White non-Hispanic, 10% Hispanic/Latinx across all races; mean age 41.66 years (*SD* = 15.92; 18-82).
- Among current users (i.e., past year use), 61% reported using at least weekly.

### Measures

- Perceptions of Risks and Benefits of Cannabis Use.

  Participants viewed a list of 38 potential benefits and risks of cannabis use and indicated the extent to which they agreed with each (1=extremely disagree; 7=extremely agree). Responses were averaged to create separate perceived risk (α=.92, M = 3.90, SD = 1.11) and perceived benefit (α=.93, M = 4.62, SD = 1.03) scores.
- Risk examples: lead to addiction, decrease motivation, cause breathing problems (18 items)
- **Benefit examples:** reduce depression, improve sleep, relieve pain (20 items)
- Cannabis Use Disorder Identification Test-Revised (Adamson et al., 2010) assessed cannabis related problems among current users (α=.86; M =10.80, SD =7.94)
- State recreational status was identified by National
   Organization for the Reform of Marijuana Laws (norml.com; as
   of April 2020)







Figure 1. Cannabis Legality by State at Time of Data Collection

## RESULTS

- A 2 (user status) X 2 (legal recreational status) ANOVA indicated a main effect of user status. Current users endorsed more benefits (*d*=1.01, *p*<.001) and fewer risks (*d*=.53, *p*<.001) of user status relative to nonusers.
- Perceptions of risks and benefits did not vary by recreational legal status, nor were there significant use status X legal status interactions.
- Among current users, cannabis use frequency in the past year and past 30 days were associated with problems (*r*s = .72, .39; *p*s<.001), but state legal status did not moderate these relationships.

### CONCLUSIONS

- Perceptions of the risks or benefits of cannabis did not vary by U.S. state recreational legal status.
- Perceived benefits and risks of cannabis may precede changes in legal policy.
- These results may have implications for policymakers and voters in states that have not yet legalized cannabis for medical and recreational purposes.
